1. Call to Order; Introduce New Members; Call the Roll; Acknowledge Guests:

2. Public Comment:

3. Approval of Minutes of the April 6 and April 20, 2016 Board Meetings:

Dr. Liebow moved to accept the minutes of the April 6, 2016 meeting. Dr. Reich seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

Dr. Liebow moved to accept the minutes of the April 20, 2016 meeting. Dr. Bernstein seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

4. Board Issues (Mr. Hoser):

Mr. Hoser and Ms. Hunter reported on their experience at the annual Federation of State Medical Boards annual meeting last month. Ms. Hunter noted that she found it to be very informative and fun, and she enjoyed meeting public members from other state boards. She stated that she felt reassured that Vermont has good processes in place that balance protection of the public and serving the medical licensees, and encouraged other public members to attend next year.

Mr. Hoser thanked members for their confidence in him to represent the Board as the Chair. He noted that this year, there was a forum for Physician Assistants for the first time and approximately 40 PAs attended. He was pleased to see PAs gaining traction. Mr. Hoser noted that he had the opportunity to serve on one of the Reference Committees that reviewed the proposed actions and reports for the House of Delegates. Mr. Herlihy added that he has the Reference Committee Materials in electronic form and that they would be uploaded into HSIN as a resource for the members.

Mr. Hoser continued with his report stating that a prominent theme for this year was focusing on Physician Burnout, re-licensure after extended leave from medical practice and prevention of physician suicide. He stated that he connected with Patricia King, MD, former Chair of the Board, and she extended her wish to come to a meeting as a representative of the Board of FSMB to talk about issues of interest, such as telemedicine and the Interstate Compact Agreement.

5. Administrative Update (Mr. Herlihy):

Mr. Herlihy continued the discussion of the FSMB meeting noting that the US Surgeon General spoke about physician wellness, stress and how to manage stress. It was reported that over 400 physicians commit suicide each year and this is not being recognized as an issue not only for the health of physicians, but also for patient safety. Other topics of interest were a 360-Degree View of Patient Safety and Medical Errors, which included discussion of establishing a duty for physicians to report errors by other physicians. Another theme that emerged during the session was that there is a trend for medical errors to be associated with practice systems and electronic medical records. With the trend for physicians to be employed in large healthcare systems, the responsibility for physicians for those systems is less direct and raises some difficult questions. Those questions include: what is the obligations of a physician for the system in which he or she practices?; and, what is the responsibility of the physician for a medical team delivering care?

Another session at the meeting was an update on graduate medical education. There is a transition taking place to having the ACGME act as the sole certifying body for all GME programs, both allopathic and osteopathic.

The Federation of State Physician Health Programs (FSPHP) held a meeting at the same site as FSMB, and there was a joint general session. That presentation also brought up the topics of physician burnout, stress, and suicide. Mr. Herlihy noted that during the most recent liaison meeting with VPHP the VPHP representatives were amenable to expansion of the program to include mental health issues, which is one step the Board can take to address this problem that is becoming the focus of attention.

Mr. Herlihy also thanked Board staff for their hard work and dedication, noting that it is Public Service Recognition Week and all staff were missing the Department of Health employee recognition breakfast because of the Board meeting.

12. Other Business:

Mr. Herlihy responded to a question raised by Dr. Reich regarding the impact that Board actions have on licensees. Dr. Reich asked if actions may have greater consequences because of the actions taken by specialty boards, and whether the Board should be more aware of that in negotiating stipulations. Mr. Herlihy explained that the American Board of Medical Specialties is the umbrella organization for specialty boards, and that under the ABMS standards each state board action is supposed to trigger a specialty board investigation. However, each specialty board has its own standards with regard to whether it will take action based upon a particular state board action. He added that a large percentage of Respondents are represented by counsel, especially Respondents who hold specialty certification. He recommended that the Board should act to resolve cases as it sees fit, and leave it to Respondents and their attorneys to raise concerns about collateral consequences. It was noted that the collateral consequences of state board actions may affect the ability of boards to reach reasonable resolutions with physicians through negotiations. Members identified this as a problem on a national level and suggested that this is a concern that could be presented to Dr. King, as the FSMB representative.
